
ORDERS:

The Management has submitted the proposals for grant of Provisional Recognition for classes I to VIII (E.M) from the year 2021-2022 (Without aid) in respect of Adani World School, Gopalapuram, Krishnapatnam Panchayat, Muthukur Mandal, SPSR Nellore District to this Office in the reference 7 read above. In turn the proposals were returned to the Correspondent with instructions to re submit the proposals vide reference 8" cited. The Management has submitted the proposals for grant of Provisional Recognition for classes I to VIII (E.M) from the year 2021-2022 (Without aid) in respect of Adani World School, Gopalapuram, Krishnapatnam Panchayat, Muthukur Mandal, SPSR Nellore District to this Office in the reference 9th read above. The Proposals were transmitted to the Mandal Educational Officer, Muthukur for obtain genuineness and visit remarks of the Mandal Educational Officer in the reference 10th cited.

The Mandal Educational Officer, Muthukur has caused inspection of the school and submitted the report to this office along with visit remarks in the reference 11th cited. After careful examination of the references cited and conditions prescribed in G.O.Ms.No.1,Edn. dated: 1-1-1994, in terms of orders of the Government of Andhra Pradesh, School Education (PS)-Department vide reference 9th cited and as per the recommendations of the Mandal Educational Officer, Muthukur in the reference 11th cited, the District Educational Officer, SPSR Nellore District hereby accorded for **grant of Provisional Recognition for classes I to VIII (E.M) from the year 2021-2022 to 2029-2030 (Without aid)** in respect of Adani World School, Gopalapuram, Krishnapatnam Panchayat, Muthukur Mandal with the following conditions. **However by the end of April every year, the Educational Agency shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by the Government from time to time and the management is requested to comply with the following without fail.**

1	That the society shall abide by the Instructions/rules regulations made by the Government or authorized officer from the time to time.
2	That the education institution shall serve the needs of the locality more particularly.
3	That the Institution shall adopt the curriculum and syllabus prescribed form time to time.
4	That the school timings, vacations and mid terms holidays shall be as prescribed by the Government from time to time.
5	That the qualified staff within the age limits prescribed by the government for Government employees shall be appointed as per the staff pattern.
6	That the results of institution shall be satisfactory every year.
7	That the records/accounts shall be furnished to the District Educational Officer or nominee every year at the time of instruction.
8	That the list of governing body shall be furnished to the District Educational Officer/competent authority every year.
9	That the pay structure/fee structure fixed by the Governing body shall got approved by the District Educational Officer or nominee every year.
10	That all the conditions prescribed in G.Os. and other orders which are not specified in this order shall be complied with. Otherwise the permission will be cancelled.
11	That the school shall not be closed without giving notice both to the parents/District Educational Officer and competent authority at least 6 months before.
12	That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
13	That the society shall submit proposals for Temporary Recognition sufficiently in advance as per G.O.Ms.No.1,Edn., Dated: 1-1-94.
14	The above Provisional Recognition is subject to a written undertaking being given by the school Management that the recognition purely on temporary basis and is subject to the reports of State Level Inspection and Vigilance Committee fulfilling of all the pre-requisite conditions under the A.P. Education Act, 1982 and if later found that the school has not fulfil any prerequisite as stipulated, that Provisional Recognition now being is liable to withdrawn at once.
15	The Management is requested to fulfil conditions stipulated in G.O 1 st read above within 3 months and submit compliance.
16	The Management is request to follow the instructions of the Fire Department and renewal the Fire Certificate from time to time without fail and submit the same to this office.
17	The Management should follow the provisions of RTE Act.
